Spotlight: Installation Floater

Installation floater covers direct physical loss from a covered peril to materials, supplies, machinery, fixtures and equipment being installed, constructed or rigged. It must be a permanent part of the completed project and installed or constructed at the jobsite. The covered property mentioned can be the insured's or similar property of others in the insured's care, custody and control. Rating basis is on gross receipts (including materials, labor costs and reasonable profit of the contractor).

Coverage Highlights:

• Debris removal: up to 25% + \$5,000

Limited fungus: \$15,000Pollutant cleanup: \$10,000

• Storage: \$5,000 (can be increased)

• Testing: \$5,000 (can be increased)

• Emergency removal: 10 days

Contract penalty: \$5,000

Sewer backup: \$5,000

• Transit: \$5,000 (can be increased)

Installation Floater v	s. Builder's Risk
Geared toward sub-contractors	Geared toward owners/general contractors
Single phase of the construction project (example: Electrical, Plumbing, HVAC)	Entire process of the construction
Does not cover "buildings, structures or land"	Includes foundations, excavations, grading, filling, attachments, permanent fencing, and other permanent fixtures
Installation "jobsite" means any location where you have work going on	Specific to the individual or multiple scheduled construction project locations
