#### **Telemedicine questions and answers**

#### Q: What can the injured worker expect from their first telemedicine appointment?

A: Their telemedicine coordinator will talk with the injured worker to determine next steps. If their visit is appropriate for telemedicine, they will be directed to a virtual waiting room and connected to the next available caregiver. If the injured worker needs in-person care, the coordinator will make the necessary referrals.

#### Q: Will telemedicine cost more?

A: Telemedicine saves time. Telemedicine visits cost an employer's plan the same as an in-person appointment, but saves money by reducing loss time from work.

#### Q: Does telemedicine protect the injured worker's privacy?

A: Yes. Telemedicine visits comply with the same high standards (HIPAA) as ordinary medical visits, and the injured worker's personal information is transmitted securely. Telemedicine providers do not record or store the injured worker's video visits.
